



# Health Warranty and Purchase Agreement

### Seller's Responsibility:

1. The Seller guarantees the puppy is in good health, is up-to-date on immunizations appropriate for the puppy's age and has been dewormed, at the time the Buyer takes possession. The Buyer has three business days to take the puppy to a veterinarian for an examination. If the puppy is found to be in poor health the Buyer has the option of returning the puppy to the Seller, at Buyer's cost, for a full refund, or keeping the puppy, and the Seller will reimburse for all veterinary costs, up to the purchase price, related to treatment of any pre-existing condition. If the puppy is not taken to a licensed veterinarian within three business days, the Healthy Warranty is void.
2. The Seller provides this warranty for twenty six months after the birth of the puppy against hip dysplasia, elbow dysplasia, eye conditions that are genetic in origin, von Willabrand's Disease, and genetic heart disorders that are serious enough to require treatment. In the event the puppy exhibits symptoms of one of these defects, the Buyer must contact the seller immediately and supply any requested veterinary records to the Seller.
3. This warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, Guardia or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, chemicals, physical injury or issues whose cause is unknown or may have an environmental link.
4. If it is determined the puppy does have a genetic disorder that is identified within twenty six months of the puppy's birth, the Buyer has the option of: either a replacement puppy from the next available litter or reimbursement, up to the purchase price of the puppy, of all veterinary expenses related to the illness. Your puppy need not be returned to us. Shipping fees will not be refunded, and if it becomes necessary to ship a replacement puppy, those fees are to be paid by the Buyer.
5. If the puppy should die from a suspected congenital defect within 26 months of its date of birth, an autopsy must be performed at the purchaser's expense by a veterinary teaching hospital or state licensed DVM acceptable to the Seller's own veterinarian. If the autopsy shows a congenital defect as the reason or the death, the Seller will provide another puppy of equal value to the purchaser. A written statement from the veterinarian must be provided. This warranty is void in the event of an indeterminable or inconclusive diagnosis.
6. Seller agrees to provide the number of the microchip that has been implanted in the puppy.
7. This warranty is non-transferable.

### Buyer's Responsibility:

1. The Buyer agrees to pay the Seller a total sum of \$ \_\_\_\_\_. This fee does not include shipping, if shipping is required.
2. The Buyer agrees that their Labradoodle or Goldendoodle will be housed indoors.
3. The Buyer agrees to feed their Labradoodle or Goldendoodle only a quality food.
4. The Buyer agrees to keep their Labradoodle or Goldendoodle at a healthy weight.
5. The Buyer agrees to make and keep annual veterinary appointments for their Labradoodle or Goldendoodle, keep all immunizations current according to the guidelines of the AVMA and properly administer heartworm preventative.
6. The Buyer agrees to provide basic obedience training with their Labradoodle or Goldendoodle puppy within the first year of owning their dog.
7. The Buyer agrees to postpone strenuous, repetitive exercise (such as agility class and running miles a day) until after their Labradoodle or Goldendoodle is over one year of age.
8. The Buyer agrees to contact the Seller immediately if the Buyer determines they are unable to keep their Labradoodle or Goldendoodle for any reason. The Buyer and Seller will determine how the dog will be re-homed.
9. The Buyer agrees to never place the Labradoodle or Goldendoodle in a shelter, pound or similar facility or research laboratory.
10. The Buyer understands that the money payed for the puppy is non-refundable unless the puppy is found to have a debilitating congenital defect as stated in this contract.
